Ministry Action Team Charter Annual Review and Three Year Renewal

Every winter SEJC meeting, all Ministry Action Teams will orally report about the state of their team vis a vis the statements of their charter. If a team reports not succeeding in following their charter, they will be given until the spring SEJC meeting to report (orally again) that they are doing so.

Every three years, beginning in winter of the '21-'22 church year, every Ministry Action Team shall submit a renewed charter, editing the form above, consistent with the Team's current membership and plans, two weeks in advance of the winter SEJC meeting. The full committee shall have the opportunity to review these renewed charters, and these updated charters will be posted to the website.

If a Team is not up to date with their charter by each spring meeting, or if they do not provide a satisfactory charter renewal, the full committee will vote on whether to disband that Ministry Action Team and remove their information from the website and other places where they are listed, and what to do with any funds remaining in the Team's account.
