#### 1. Minister transition update presented by Lin

Need prep team: president, one board member and BUF member not on board.

- Communications with BUF congregation: small meetings after church on Zoom and occasional announcements.
- Protocol and procedure proposal for choosing Interim Minister.
  - Proposal: Transition and prep team be the same committee as the Interim Minister recommendation team. This committee will make a recommendation to Board.
  - Different team for settled minister search—congregation and board choose search team (7 people on search)-congregation picks 4 and board picks 3.
  - Time line starts January 2025 but information goes to congregational earlier.
  - Lin asked for approval to set up the committee of three people one board member and one at large member of BUF.

John moved that Lin be authorized to appoint herself, one additional board member and someone at the congregation at large to serve as members of the interim search team and

be responsible for the for the first four steps in the Ministerial Transition document. Beth seconded. Motion passed unanimously.

Key dates in BUF Ministerial transition period 2024-2027 (approximate dates)

- Jan-Feb 2025: Board meets with UUA staff to preview timeline and process
- Jan-Feb 2025: Board creates a plan for ongoing communication with the congregation.
- Jan-Feb 2025: Board ensures we have sufficient funds to hire an interim minister.
- Mar-Apr 2025: Interim search team recommends and interim to the board.
- Apr-May 2025: Board hires an interim minister.
