Monthly Treasurer's Summary Report to the BUF Board of Trustees January 2025 Financials (58% of the fiscal year) Prepared for the February 27, 2025, Board Meeting

Project Status:

Completed tasks:

- Creating separate income categories when pledges are received via Breeze.
- Started working with Summit Bookkeeping to provide support to the accounting/bookkeeping process.

Internal Financial Statements Review:

- An internal review has been underway for the fiscal year July 1, 2024 June 30, 2024.
- The team conducting the review is Sharon McCarty, Haven Silver, John Jurceka, with Sky Hedman acting as the convener of the status meetings and a compiler of the final report for the Board.
- A draft report has been received and was discussed at the latest FOC meeting. There are a number of issues to be addressed, and the report will be forwarded to the Board as soon as comments are received from the pertinent areas of the operation.

• Humanitas Changes

- Humanitas has had a complete change in leadership, with Erika, Tammy and Stephanie all exiting, being replaced by Constance Ohana, Henry Ohana and Joan Mackay.
- Although we had developed process to permit Humanitas to stay on Vanco, as they originally desired, the new team wishes to move to Breeze as soon as possible.
- Signers on the Humanitas account have been updated to reflect the change.
 It is recommended that the Treasurer always be a signer on the Humanitas accounts.
- Humanitas income and expenses have generally not been recorded in BUF's books, with most transactions going straight to their designated fun account. Beginning with the next fiscal year, we expect to begin recording Humanitas income and expense as BUF transaction under their ownb expense class, similar to SEJC.

• Downloading Transactions into QuickBooks:

- Further expansions of downloading (Breeze, OnPay, etc), has not proceeded while bookkeeping issues are resolved.
- Vanco, which is used by Humanitas has an interface with Breeze and will be tried in coming weeks. This will no longer be pursued.
- OnPay advertises that they have an integrated interface with QBO. This will be tried as time permits.

• There is no interface between Breeze and QBO that will meet our needs. John is working with John Jurceka and Michelle to develop a specific set of procedures for recording Breeze transactions on QBO

Review of current financial reports.

• See attached Minutes of the Financial Oversight Committee and accompanying January 2025 financial statements.

Additional Comments

- **Cash on Hand** for January has improved and sits at approximately \$59,000. There are 3 items of note which are temporarily contributing to the improvement:
 - o A \$10,000 contribution to the Endowment Fund which will be moved to the UUACEF.
 - Approximately \$15,000 in paddle call contributions which ware being moved to the reserves.
 - o A \$10,000 donation which was earmarked various maintenance projects (as accepted by the Board).
- **Pledge Income** through January is essentially on track for the year at \$219,000. At this point, our hope is to collect pledges we received.
- YTD Overall Donation Income is \$264,000 and ahead of budget.
- **Building Rental** is \$13,000, short of the budgeted \$17,000. We expect this to continue to struggle until we gain more tenants.
- Net Operating Income (NOI).
 - 1/31/2025: We show a month's operating surplus (Net Operating Income) of \$17,000.
 - YTD 1/31/2025 We show a year-to-date operating surplus (Net Operating Income) of \$88,000, which is \$40,000 ahead of budget. This will be reduced by the Cash on Hand adjustments described above and will revert to a YTD surplus of approximately \$5,000.

Members of the Financial Oversight Committee are John Stewart (Treasurer), Sky Hedman (Assistant Treasurer), Frank McDonald (Assistant Treasurer), Sue Sayegh, Lew Phinney, Rupert Ayton and Patricia Conover.

Treasurer's Summary Reports and selected Financial Reports generated by Administrator are placed by the Administrator in BUF Workroom.

Cash On Hand reports:

Assets that are available to Board under normal operating conditions: Checking, Savings, and Accounts Receivable. (It does not include Endowment, Humanitas, A. Herrmann Social Justice Account.)

Equity that is subtracted from Assets are those that are not available under normal operating conditions: Restricted Funds and Designated Program Funds. Liabilities are adjusted to include only one month of the Principal payment for the mortgage.

Financial Statement Reviews

• Review of January 2025 financial reports

- a. Approximately \$7,000 in old accounts payable which were reexpensed over a year ago.
- b. Approx \$4,000 in expenses put on Visa twice.
- c. Rental income approximately \$4,000 under budget. This trend is expected to continue.
- d. Donations are approx. \$14,000 ahead of budget.
 - i. Of that, pledge income is approximately \$1,000 behind budget, but expected to be collected.
 - ii. Taize gift is \$5,300 ahead of budget, but \$3,100 of that will be rolled to next year.
 - iii. Non-pledge/Friends donations
- e. Cash on Hand is positive \$59,000, reflecting high WECU checking account balance. Excess WECU funds are the result of the following:
 - i. A \$10,000 contribution to the Endowment Fund which will be moved to the UUACEF.
 - ii. Approximately \$15,000 in paddle call contributions which ware being moved to the reserves.
 - iii. A \$10,000 donation which was earmarked for various maintenance projects (as accepted by the Board).

- Kyle's relevant comments on January's statements are:
 - a. My understanding is that the ~8400 in the Accounts Payable from prior years is all in paid up and just needs to be cleared out of the account. Is that correct?
 - i. Per Rupert: The \$8440 in A/P all seem to be erroneous entries that need to be reversed or eliminated in some way. The 2 sticky ones are the partner church and the mortgage. They may need a little research to figure out how to unwind them. The rest just seem to be duplicates or errors and should be as simple as pushing the delete button
 - b. The Refund on the 941tax payment from 2021 got put in the Uncategorized Income account. We generally try to not leave anything 'uncategorized'. I would recommend we make an Other Income / Non-operating Income account for "Tax Refunds" or "Prior Period Refunds" and put the income in that account.
 - i. OK to proceed.

Outside Accounting Support

- Work with Kyle at Summit is starting well.
- A status meeting with Kyle is recommended to discuss progress and changes.

Internal Review of Financial Statements

- Final draft report was reviewed and discussed.
- "Owners" of the pertinent areas of BUF will be asked to respond to issues raised in the review.
- After comments are received, the final report will be forwarded to the Board.

Budget Draft

SEJC Executive Summary

The following is an executive summary of the Community Beyond BUF Council which includes BUF's Social and Environmental Justice Committee and Covenant of Beloved Community programming. This summary covers from October 2024 through January 2025 and only includes BUF activities; however, more detailed information and information from other denominational organizations are included in the full report that follows.

The Social and Environmental Justice Executive Committee monitors SEJC team programming, funds and whole committee meetings. SEJC continues looking for a Chair, Vice Chair, Secretary, and Communications lead. From October 2024 to January 2025, the SEJC executive approved approved use of BUF spaces for Whatcom Peace and Justice Center's "Report Back From The West Bank" program (Palestine), Adam Manasra speaking on his life in the West Bank (Palestine) before October 2023 and the annual Native American Heritage Day Concert. They also approved financial sponsorship of Kuntz & Company social justice dance film series and a donation to the Fatherhood Foundation for programming during Black Excellent Month.

Black Lives Matters meets every month conducting program and business meetings. BLM continues building its relationship with the Synergy Group. BLM held two services on Martin Luther King, Jr. and Inauguration Day and another on the Practice of Beloved Community. Two events were held around MLK, Jr holiday including "An Inconvenient Hero" with Dr. Clyde Ford and the 25th Annual MLK Jr. Celebration with Dr. Sislena Grocer Ledbetter. BLM is also hosting 4 sessions on Beloved Community with Revs. Mel Hoover and Rose Edington in February 2025. BLM requested an SEJC donation to the Fatherhood Foundation for programming during Black Excellent Month.

Environmental Justice BUF members continue to be a part of the Multifaith Network for Climate, interfaith efforts continue in breaching the Snake River supporting salmon and our Southern Resident Orcas and the UU Climate Justice Coalition. Activity with legislative advocacy is expected to pick up and responses to the Trump administration's environmental attacks are being prepared for. Hosted an Indigenous Climate Cinema Showcase with Fred Lane of Lummi Nation in January 2025.

Humanitas Humanitas gave assistance to 60 clients in the period of October 2nd and December 18th of 2024. Gasoline, utility bills and transportation (which includes bus tickets and car tabs) topped the list of requests.

Immigration Rights. The Immigration Rights team was to be suspended; however, is being reactivated due to the Trump administration's immigration actions and policies. Engagement with C2C is being revived and an interfaith group is being formed. Other contacts include collaborations with UUSC and UUSJ and a national UU Immigration response team.

The Interfaith Coalition. BUF member Lucy Kesterson was hired by the Coalition as program manager, joining BUF member and representative Rev. Rose Edington. We participated in the winter coat drive and continue with CAST (Coffee and Sandwiches Together) program. IFC is providing regular meetings for clergy in Whatcom County to gather, get to know one another, and share outreach

programs so that congregation can more easily cooperate on meeting community needs. Two meetings were held this fall and more are planned. The Annual Auction is coming up in May.

UPLIFT (**formerly Interweave**) Uplift has been transferred over to the Community within BUF council and, after this, no longer providing updates to this report. They will be concentrating their efforts internally to BUF and will offering up the Transforming Hearts' "Trans Inclusion in Congregations" course March 2nd – April 6th Sundays from 3-5 pm. A team to assist trans migration into Canada is currently being formed with UUSC, BUF members, Whatcom queer and LGBTQIA+ organizations and the First Unitarian Fellowship of Nanaimo (British Columbia). Work with the Pink Haven intercontinental migration LGBTQIA+ folks continues.

Native American Connections Committee continues working on several projects with Lummi Nation members including the Gathering of the Eagles, Toki TV and other actions. Work continues with local and state interfaith organizations and projects. Held annual Native American Day Heritage Concert. Coordinated introductions for funding research to members of Lummi Nation including the House of Tears Carvers and Whiteswan Environmental and continued to support Children of the Setting Sun Productions. Promoted Pickford films, the Netse Mot and other indigenous events. Continue planning Gathering of the Eagles (May).

Refugee Resettlement Team continues to support two Syrian families through ongoing tutoring, language support, cultural opportunities and building community. Work continues to help the Alhoori family get their cleaning business off the ground. In November there was a Syrian Cultural Celebration dinner that raised \$2,000.00. Federal funding frozen by the Trump administration has left had a devastating impact on refugee families. Spring Mattress drive for World Relief refugees is in the planning.

Fair Trade Sales has 2 new FT sellers Allison Jones & her friend Marsha Volkommer. They sell the first Sunday of the month. Sita is in India until late March. New payment option-Text to pay for your FT purchase is in the works, more details to come.

Special Collections table in the full report lists the recipients for the 204-2025 year and the amounts raised. The largest being raised for the Interfaith Coalition.

Unitarian Church of Magyarszovat in Transylvania, Romania has nothing substantial to report over the past few months.

Whatcom Racial Equity Commission Miriam Karamoko was named executive director in July and will be meeting attending a retreat to discuss their 12 focus areas that include economic mobility, the justice system, education, mental health, systemic and structural racism, health, environmental justice, food security, housing, substance use, immigration and county participatory processes.

Covenant of Beloved Community still needs volunteers to nudge our congregation in continuing the goal of achieving Beloved Community which appears to have stalled out except for SEJC activities.

- Approved use of BUF spaces for the annual Native American Heritage Day Concert.

Actions of the Social and Environmental Justice Committee of the Whole

At the January 2024 general SEJC meeting, the following items were discussed or taken action on. A copy of SEJC's Charter is included in the Appendices section.

Next scheduled SEJC meetings are: April 27, 2025 • Sept, 21 2025 • January 25, 2026

- Time was giving to members to share a few minutes on their reactions to the onslaught of executive orders coming from Trump administration.
 - Most comments were reflecting the extreme actions against the LGBTQAI+ community, the environment and immigration in particular refugees and the rollback of protections and the cultivation of fear by our elected officials.
 - Concerns were also raised regarding ICE raids, farmworker deportations and the raising costs of food.

- o Concerns were raised about the significance of staff government turnover and a possible bright spot with the new director of the Bureau of Indian affairs.
- The SEJC committee voted to pay \$89.16 to cover the UU the Vote expenses from the last election cycle activity (fall of 2024). Henry Ohana made the motion, Constance Ohana seconded. Passed unanimously.
- The Anti-racism fund had \$10.00 left in it. Since it is a restrictive fund, the owner of the fund needs to be contacted. Deb Cruz opened the fund during the time of anti-racism training and has agreed to transfer the balance to the Black Lives Matter account.
- Deb reported from the Ops team that BUF is overbudget in the use of building stewards and AV techs and many AV techs are not available in the evenings. Any events planned need to keep this in consideration and volunteers will be needed to do both AV services and space set up and clean up. The AV staff has made it significantly easier for BUFsters to run their own programs using the Bose system which is now secured to the floor on the dais. Also, teams can apply to the Executive Team for funds to pay for AV services once an AV tech is scheduled.
- Beth Brownfield announced the scheduling of an Earth Day Service and calling on volunteers to help design the program. The idea is to design a service similar to the service that was held at First Congregational Church last year with BUF's and other's participation.
- It was reported that Annie Sorich will be working with the BUF website redesign. We will need to confirm so the SEJC can have input to their section of the website redesign.
- Upcoming will be the incorporation of Fair Trade into the Breeeze system. More details to come.

Black Lives Matter

Black Lives Matter continues to meet monthly. It's been revealed there is a common feeling that worship services have not been using diverse voices and that the commitment to antiracism and Beloved Community was inconsistent—and sometimes absent. A person of color coming for the first time to BUF easily might have the impression that ours is a mostly white and privileged congregation



with little to recommend it to them. Rupert joined the Celebrants' team so that he would have a space at the table, and with Paul and the team his presence has made a difference for both deficits.

We have been very active in January, leading 2 worship services, and with a presence in 1 other, and we have sponsored and helped with two well attended and helpful community events at BUF for MLK Day.

- "Martin Luther King Jr.: An Inconvenient Hero" on Friday January 17, is sold out.
- "The 25th Annual Celebration of MLK Jr. Day, Monday, January 20, at 7 pm, with volunteer choir rehearsal at 6 pm, at BUF. Please come for uplifting music, and a keynote address by Dr. Sislena Grocer Ledbetter.

In February, Lucy will take the lead with 4 classes on the general theme of Beloved Community with Rev. Dr. Rose Edington and Rev. Mel Hoover. There will be 4 sessions - Sundays, February 2–23, 12:00–1:30pm. In 2020, BUF adopted our Covenant of Beloved Community. The Black Lives Matter Action Team invites you to join us in exploring what living the promise of our covenant means in practice. Participation in all four sessions is encouraged but not required.

Events

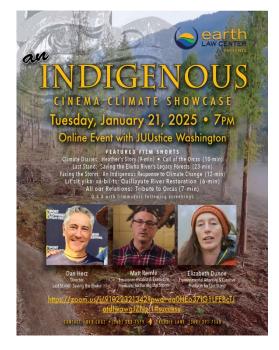
On January 23rd, BUF hosted Lummi Nation member Freddie Lane's Indigenous Climate Cinema Showcase. With Freddie Lane moderating, attendees watched several film shorts on indigenous perspectives of climate change and its impacts. Guest speakers Elizabeth Dunne and Matt Remle zoomed in to speak with attendees. Films included:

- Last Stand: Saving the Elwha River's Legacy Forests
- Climate Diaries; Heather's Story
- Call of the Orcas
- Quillayute River Restoration
- Facing the Storm: The Indigenous Response to Climate Change
- All Our Relations: Tribute to Orcas

Deb Cruz has reached out to area environmental NGOs to begin building a coalition to keep the current federal

administration's downgrading the priority of environmental justice and climate change. The current administration will be moving to expand fossil fuel exploitation and production and it's felt that the PNW will be revisited as the fossil fuel hub.

There are also other activities to be concerned with including the former Intalco site on Cherry Point becoming a hydrogen facility, part of the federal hydrogen hub program.



Multifaith Network for Climate Justice.

The Multifaith Network for Climate Justice is scaling back its programming efforts due to the availability of people to organize and plan events. The steering team will continue to meet to address special program and the email listserv will still be available for members to post activities and events and encourage discussions.

Earth Advocacy Partners.

Deb Cruz attends monthly meetings with Earth Ministry (https://earthministry.org) and other faith representatives to keep up-to-date on WA State environmental legislation and other activities. Earth 2025 legislative priorities: https://earthministry.org/2025-legislative-priorities/.

Climate Justice Coalition.

The Climate Justice Coalition includes representatives from UU Ministry for Earth (UUMFE), UU Service Committee (UUSC), Side with Love, UUs for Social Justice (UUSJ), UU Women's Federation, DRUUM, UUs for Economic Justice (UUEJC), College for Social Justice (CSJ) and other national, regional and state UU teams working on environmental and climate justice have convened a new national team called the Climate Justice Coalition. One thing the Coalition will be working on is bringing all these groups, their perspectives, goals and resources into one space so a more united front can be developed to counteract what's coming in the days ahead under the current federal administration.

In October, the Coalition completed its conflict management training with Kai Cheng Thom. In January, the Coalition completed its training on Liberation Logic Model. The session explored what the domination model is and how it operates and the difference in shifting to the liberation logic model that invites us to use love, joy and a deep understanding of ourselves and our context to co-create a better world.

Snake River Dams.

Efforts continue to breach the lower Snake River dams in order to restore salmon populations, particularly Chinook that are critical to Tribal communities and our Southern Resident Orcas

Commenting processes have been and are being conducted on the recreation, agriculture and transportation replacement benefits. These studies and surveys will help in identifying the kinds of changes that will be made should the dams be breached. So far, both the transportation and agriculture

(water) surveys and studies suggest that breaching the dams will not have a significant impact. There will be some work to be done, but will not be an unreasonable barrier to the breaching.

Folks are encouraged to contact their congress folks to breach the dams with an emphasis of informing the new congress people of the need. People are also being encouraged to bring the new Governor Bob Ferguson up to date as well as new legislators elected this past November.

Immigration Rights

Already the new federal administration is well underway in building up for ICE raids and mass deportations. Normally "safe" spaces, such as schools and churches, will no longer be exempt from these raids. Other efforts include redefining birth citizenship which is going before the courts, preparing the military for immigration action, deportations without hearings, non-citizen registration, invoking a national emergency at the southern border, work permits only to those of legal status and more. Local Actions

Deb Cruz has been added to solidarity network that Community to Community is building. This will be for notifying folks of farmworker needs. Anyone wanting to be added to this list, contact Liz Darrow at lizdarrow@foodjustice.org.

Both Mike Betz and Deb Cruz attended a Whatcom interfaith meeting discussing the potential of collaborating in resisting ICE and current Trump immigration policies and actions. Ann Stevenson and Michael Berris are also working with Indivisible Bellingham who are also working with concerned agencies and organizations around collaboration efforts. A February 17th program with Bellingham Public Schools Superintendent Greg Baker and a March 17th program with immigration attorneys is being planned.

At the UU National Level

Collaboration with national UU partners is being developed more substantially. There is a request from UUSC for potential action for BUFsters and area LGBTQAI+ allies in the Bellingham area in providing support for folks crossing into Canada. UUs for Social Justice's Immigration Team will also be reaching out to congregations, are looking to establish a collaborative culture for federal advocacy and sending out calls to action and programming. Deb Cruz will be engaged with a national UU immigration response team that is being created with UUSC, UURise and others.

Statement on UUA Suit Against the Administration

Washington, D.C. — The Unitarian Universalist Association (UUA) joined more than two dozen Christian and Jewish religious denominations and associations on February 11 in filing a lawsuit against the Trump Administration's new policy that allows immigration raids, arrests, and other enforcement actions at houses of worship. The new policy empowered enforcement actions that could interrupt religious services in furtherance of the Administration's mass deportation plans. The Trump Administration's rescission of the Department of Homeland Security (DHS) "sensitive locations" policy that had restricted Immigration and Customs Enforcement (ICE) from conducting immigration raids, arrests, and other enforcement actions at houses of worship is a violation of the broad protections for individuals performing religiously motivated actions.

General Events and Activities

• SEPTEMBER

Toured 2 employees of a Non-Profit I met this summer in South Dakota, along with Peach Tarver of Indivisible, through Lummi Nation and introduced them to Freddie Lane (House of Tears Carvers), Shirley Williams (Whiteswan Environmental), and Jewell James (House of Tears Carvers). They are both working on a research project to better understand the relationship between philanthropy and Native communities. The goal is to educate funders and help facilitate more funding to Native organizations. Some funders want to do more but may not understand how to help -- both in terms of technical/legal requirements and connecting with prospective grantees. Similarly, we've talked to some people and organizations who feel they aren't on the radar of foundations. We'd like to help bridge that gap.

We were beautifully hosted by Freddie, Shirley and Jewell and spent over an hour or more with each of them. The two were invited by Freddie to join them on a day canoe journey throughout the local area with tribal residents who were out practicing their canoe skills and learning about Lummi Culture. Close bonds were made.

OCTOBER

- Publicized information about the gifting of the Mindport building to Children of the Setting Sun Protection (CSSP)
- CSSP will use the three-story building to create Setting Sun Labs, "a vibrant lab space, that will share films, podcasts, events, a digital heritage library, immersive media and contemporary art", and will also include an immersive experience gallery, a Coast Salish

- lifeway gallery, a digital media production studio, maker spaces and an artist-in-residence program. Construction planned for spring 2025 and projected to open in spring 2026.
- O Promoted free Storytelling mentoring with Lummi, Swil Kanim the second Tuesday Nov-April at NW College Library.

NOVEMBER

Distributed the story about Activist, Chris Elder who gathered 1,200-1,500 lbs. of fresh meat and vegetables from local farmers and transported them by BARGE down the Nooksack River to Nooksack Indian Tribe and Lummi Nation for distribution in time for the Thanksgiving food distribution.

Chris wrote: "Thanks to all of you for joining me in a somewhat unconventional attempt at supporting our communities and supporting each other along the way and connecting

with the world around us. Thanks also goes to the Nooksack River and all the many ways it supports us, connects us, and enriches us and the world around us. I am very grateful for all of you and all the other folks that play a role in our food systems and communities."

- o Coordinated an anonymous BUF member who wanted to donate part of an inheritance to Lummi Shirley William's, White Swan Environmental program. We spent several hours with Shirley and a generous amount was passed to her to support one of her ongoing projects. It was a beautiful interchange.

Refugee Resettlement Team

The Refugee Action Team met January 13, 2025 via Zoom to continue planning for future efforts. Many needs for the families were discussed including birthday events, the new cleaning business in the Alhoori family, language and literacy supports, future mattress drive for World Relief refugees etc. There are over a dozen team members who continue to provide language and literacy tutoring, job

hunting, driving lessons and more. Recently, a computer and a car were donated to support their growing independence.

On November 16th, the team helped sponsor a Syrian Cultural Celebration Dinner with 96 dinner reservations. \$2,000 dollars was raised to support 3 local refugee families (2 Syrian and 1 Sudanese) and one Syrian family in Turkey. A full menu with Syrian family cooks included: BBQ Kabobs, Kibbeh, Baked Salmon, Biryani spiced rice, Syrian Red Lentil soup, Hummus, Green Salad. A short program presented family celebrations and sharing of the refugee experience and then authentic music and dancing. A fabulous time was had by all.



A discussion about sponsoring another refugee family from World Relief was discussed and then tabled due to the lack of volunteer availability to undertake such a task at this time. In the meantime, some members of the team will proceed with a mattress drive to support all the incoming refugees in World Relief.

Special Collections

The SEJC Special Collections from BUF congregants support Whatcom County not-for-profit social justice organizations to fulfill our objective of outreach beyond BUF. Our congregants offer their time, skills and effort, as well as money, in caring for people and environment. This reflects our shared values of Justice, Equity, and Interdependence.

Consistent with our values, we invite applicants and select in six categories: women/children, poverty/homelessness, peace/human rights, social/economic justice, health, and environment. The representatives of the applicants appear for an interview for defense and a question/answer session, and those of the recipients appear at their scheduled collection Sunday service for a five-minute pitch for their cause, and have an option to set up a table for information for the congregants, in the social hall during coffee hour.

In recent years, guided by our Beloved Community promise, we broadened the circle of outreach to be inclusive of newer programs and fledgling local organizations. We reached out to you, our congregants, to encourage any such non-profits you know of, to apply for our grants. As a result, in the last few years we netted several organizations serving a diversity of marginalized and previously unfound categories, ranging from a program to reintegrate released incarcerated people into the mainstream community (Restorative CommUnity Coalition) to a project in environmental sustenance (Ten Thousand Trees). In addition to the ten recipients for 2024-25, listed below, two months are set apart for BUF's Humanitas program and Magyarszovat, our Transylvanian partner, and we take an additional collection on Christmas Eve for the Interfaith Coalition).

The members of SEJC appreciate the generous contributions of BUF congregants, and we will continue to be committed to BUF's Covenant of Beloved Community.

Social Environmental Justice Committee Charter. Bellingham Unitarian Fellowship

Mission Statement. We affirm and promote peace, justice, and equality through action, education and raising awareness within our community and the wider world.

II) The Purpose of the Committee:

- 1- To select non-profit organizations for educational events, hands-on service projects, and Social & Environmental Justice Sunday Collections.
- 2- To sponsor social justice-related building use and events.
- 3- To represent the Social & Environmental Justice Committee and our UU values at community events through sponsorship and/or participation.
- 4- To disseminate Social /Environmental Justice Information through sales, special community events, and demonstrations.
- 5- To respond to immediate needs and injustices in our community and the world.

III) Committee Governance:

- 1) The Social & Environmental Justice Committee of the Bellingham Unitarian Fellowship shall constitute the overall policy-making body for implementing the Purposes of the Committee.
 - A) Committee size: The SEJC shall endeavor to maintain fifteen (15) voting members, including an elected Chairperson, Secretary and Treasurer, one person from each sub-committee appointed by the chair, and the Unitarian Universalist Service Committee Local Representative.
 - B) Quorum: A quorum will consist of eight (8) members of the committee who have attended no less than two of the previous three meetings.
- 2) The Social & Environmental Justice Committee of the Bellingham Unitarian Fellowship shall meet three (3) times each year, including late summer, mid-winter and spring.

 A) Meeting dates will be set one year in advance.

- 3) The Social & Environmental Justice Committee of the Bellingham Unitarian Fellowship shall have five (5) standing Sub-Committees including, but not limited to, the following: Executive, Finance, Communications, Programs, and Nominating.
 - A) The Executive committee will be made up of no less than five (7) officers, including the Chair, Vice Chair, Nominating Chair, Treasurer, Action Sub-Committee Chair, Secretary, and Communication Chair.
 - B) The Executive committee will execute all the powers of the full committee during intervals between meetings of the full committee, except for approving annual budgets, electing new officers, creating new committee policies or reversing any committee actions approved by the full committee. The SEJC Chair shall have the authority to spend up to \$50 for committee expenses between meetings of the full committee. The chair may do this up to three times between meetings of the full committee.

The SEJC Executive Committee shall have the authority to spend up to \$200 for committee projects by a simple majority vote of the Exec Committee. This option may be used up to three times between meetings of the full committee.

- C) The Finance sub-committee will be chaired by the Treasurer and will include two (2) other members. The committee's primary responsibility is to create an annual budget and take the lead role with fund raising.
- D) The Communication sub-committee will include three (3) members with one member also serving on the Executive committee. The committee's chief responsibility will be the dissemination of committee-approved information. A member of this committee will also attend the BUF Program Implementation Group meetings.
- E) The Actions sub-committee will include no less than five (5) members with one member serving on the Executive committee. The committee's chief responsibilities will include: gathering information on organizations and projects to submit to the full committee for possible support, and aiding BUF small group social justice ministries. The committee will prepare a report in April of the full committee's work to be presented at the spring meeting of the full committee and presented to the congregation during the May Congregational meeting.
- F) The Nominating sub-committee will include no less than three (3) members. The committee's chief responsibility is to maintain the membership of the full committee at no less than fifteen (15) active members.
- 4) The Social Justice Committee of the Bellingham Unitarian Fellowship shall be governed by Roberts' Rules of Order.
- 5) The Social Justice Committee of the Bellingham Unitarian Fellowship may amend the committee policies with a two-thirds vote of the full committee.

VI) Principal revenue sources:

- 1) Direct, unrestricted donations by individuals, or through group fund raising events.
- 2) Revenue through the sale of Fair-Trade products. The Unitarian Universalist Service Committee, working in partnership Equal Exchange, set up a program for congregations to

- sell Fair-Trade products. SEJC members Bob and Dorthy Davis started this program at BUF with a donation for the purchase of coffee and other products. They organized volunteers to sell these items during the coffee hour each Sunday and ran this program for many years. Bob and Dorthy are now both deceased. Susan Thurm took over the management of this program which provides a modest income for the committee and promotes the use of Fair-Trade products.
- 3) BUF member Adele Herrmann passed away in 1994 and made a bequest of funds. Adele explicitly stated that the funds were to be used by the Social Justice Committee of the Bellingham Unitarian Fellowship. Her generosity reflects her concern for those less fortunate souls in our community, and her gratitude for the friendship and support she received from her fellow BUF members.

Social Justice Committee member Virgina Addis aided Adele in her final days. Long time BUF member Brian Hanson was the attorney that handled Adele's estate. At the time of Adele's death, Coral Dudek was BUF's administrator, the Reverend Barbara Cheatham was the minister, and Todd Jones was the Social Justice Committee chair. Each of these people knew Adele and had knowledge of Adele's final wishes.

The Adele Herrmann Funds have been managed by the Social Justice Committee (later renamed The Social Environmental Justice Committee). The committee decided to use the money as needed over time and voted to invest the funds with a firm specializing in socially responsible investments, Domini Investments.

Over time the funds increased in value more quickly than the committee was using them. The committee voted to adopt a policy to use 5% of the total value of the portfolio at the end of each church year. These funds currently provide most of the committee's unrestricted operating budget for the year. While the Bellingham Unitarian Fellowship is the fiduciary for these funds, the management and allocations are exclusively the charge of the Social Environmental Justice Committee as per Ms. Herrmann's wishes.

Note: This document was adopted in October 2010 and adjusted as needed by a vote of the committee.

February 2025 Minister's Report to the BUF Board Rev Paul Beckel

1. Safety Team

- a. Fire Marshall has given us the all-clear on our existing exit signs (no new signs needed, a few were removed at his direction); he was also ok with our new evacuation maps.
- b. New first aid kits have been installed on each floor. Those floating around in random places (along with two fire extinguishers not serviced since 1996) have left the building.
- c. The Safety Team now has an excellent annual calendar to ensure follow up on safety drills, monitoring materials, etc. I'm concerned that we won't get new volunteers to follow up.
- d. Other projects for which we need volunteers:
 - i. Password management and controls
 - ii. Key management and controls
 - iii. Security systems: our systems are operational but no one really understands them or would know what to do if there was a problem

2. Website Update

- a. Working as a contractor, Annie Sorich is creating a new website from scratch. She has met twice with me, Michelle, and Scott Heise (who created/manages our current site).
- b. Annie has spoken with Rory Mcleod about software requirements, costs, compatibility with our other platforms, and transferring buf.org to a new host. She's spoken with current users and random others to get a sense of what works on buf.org and what does not.
- c. She is now working on a prototype. As it's being built, she'll consult with leaders of BUF primary groups. Prototype, perhaps, to be ready in the fall.

3. Human Resources

- a. I'm working with the HR team to establish a better process for employee timecards.
- b. Our Administrator job description needs to be revamped. We're paying Michelle to do a lot of things that we should have volunteers doing. She can't get to some of the things that only she can do because she's cleaning up after renters, etc. In order to right-size the Administrator position we may need to plan for less rental income.

4. Other major things on my to do list

- a. Help determine who to canvass
- b. Fix anomalies in Breeze, improve processes for data upkeep
- c. Review hours and actual costs vs budget for Building Stewards, Teachers, Childcare, AV
- d. Develop a process for maintaining a buildings and grounds task list

- e. Review last few years of my payroll vs contracted compensation
- f. Building use policies, rental procedures

Replacement Account Signers for Humanitas

There are big changes in Humanitas as Erika Shepherd, Stephanie Bowden and Tammy DeRossett, who have comprised the leadership of the program, have all elected to retire from their roles. As you may have heard, Erika has apparently had some serious health issues which may contribute to this decision. Time is of the essence in this proposal, which is why it is not being held until the next Board meeting.

Fortunately, Constance Ohana, Henry Ohana, Joan Mackay and others have stepped up to ensure the continuity of the program, which has operated under the auspices of SEJC. For those who are less familiar with the operation, I've attached their SEJC Charter Renewal from several years ago and which needs updating as far as personnel goes but gives an idea of what they do.

Humanitas has had separate checking and savings accounts from the rest of BUF for a number of years; Erika, Stephanie and Tammy are the currently-authorized signers. In my short history, I don't remember the Board having been asked to change those signers, but it needs to happen now. WECU has declined to remove them as signers until a "Governing person" has approved it. There are good reasons to continue the separate checking and savings account arrangements, given the nature of their program.

I'm sending this email in order to propose a resolution to remove the existing signers and appoint new ones. I believe that the Board Treasurer should always be a signer, in order to prevent something like this from happening in the future. Other signers will be those who actually run the program: one of them needs to be on site every Wednesday to sign checks as needed.

I request that the attached resolution be adopted via email and confirmed at the next Board meeting. Unanimous approval is required for a proposal of this nature.

Follow-up

Following unanimous approval of all Board members, the signing resolution was forwarded to WECU and the change of signers was accomplished.

Subject: Potential BUF Organizing, Strategizing and Acting to support the Covenant of Beloved Community

(We will discuss different aspects of this proposal and are sending to you early so you have the background—Claire)

On behalf of the approximately 30 BUF members and friends attending the February 9, 2025 Adult RE Beloved Community Study Group, we, Rose Edington, Mel Hoover and Lucy Kesterson (the co-facilitators) forward this request:. That the BUF Board take a public stand in support of those being marginalized and oppressed by recent government actions.

Public actions in support of this request could include:

In the spirit of the above request, an opportunity for an immediate action of support would be for the BUF Board to affirm and thank the UUA (through President Sophia Betencourt's office) for the UUA's decision to "join a multifaith coalition to challenge the ending of ICE's (Immigration and Customs Enforcement) sensitive locations policy and to oppose any interpretation of law which would allow immigration raids in houses of worship and religious ceremonies. We believe, and the lawsuit asserts, that subjecting places of worship to ICE enforcement actions without a judicial warrant substantially burdens our religious exercise in violation of the First Amendment and the Religious Freedom Restoration Act."

We request that the Board follow the example of First UU in Portland OR and place a sign on the doors that reads: "PRIVATE PROPERTY NOTICE: This church is private property. Unauthorized entry, including by ICE or Homeland Security without a judicial warrant is not permitted."

We request a BUF Congregational Meeting to discuss the UUA's suit as well as how to proceed locally in support of BUF's BELOVED COMMUNITY COVENANT by educating, organizing, and acting in support of oppressed people. We are especially concerned that "Diversity, Equality and Inclusion" is being systematically removed from government agencies (including funding) and how this is affecting our State, County, and City.

We want to work with the BUF Board and congregation to educate and organize in order to become a Sanctuary Church that is seen as a safe space for those in need of sanctuary

As our <u>UUA</u> Executive Vice President Carey McDonald affirms, "As Unitarian Universalists (UUs), fighting for justice and liberation for all people is at the heart of our faith tradition, which recognizes the spark of the divine inherent in every person; our sacred spaces must continue to offer sanctuary to those who face oppression, violence, or alienation, including immigrant communities."
