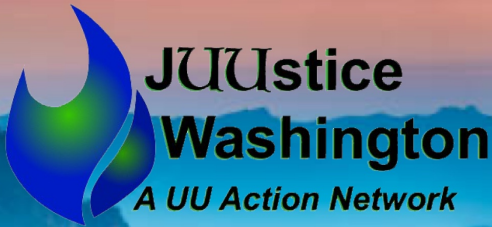

Oppose new rule on biometric information - UUSC Resistance Network

Under a new proposed DHS rule, the Trump administration seeks to harvest intimate biometric information on just about everyone who interacts with the immigration system—including U.S. citizens, children, and the elderly. One line of the proposed rule even states that “DHS may request DNA evidence to prove or disprove an individual’s biological sex in instances where that determination will impact benefit eligibility.” Such language could also be used to deny noncitizens asylum or legal protections under the Violence Against Women Act, based on this administration’s unscientific and discriminatory definitions of gender and “biological sex.”

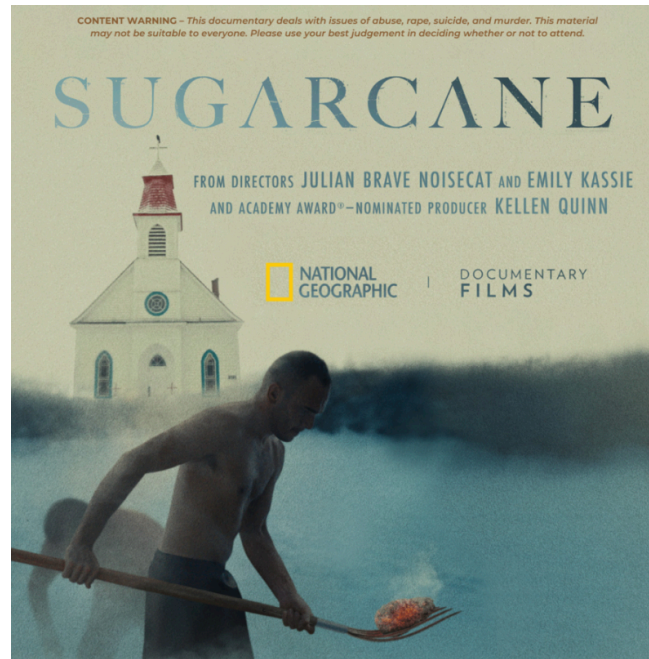

National Forest Thinning Project

Sierra Club

The U.S. Forest Service (USFS) has proposed a massive, forest-wide thinning project on the Mt Baker-Snoqualmie National Forest (MBSNF) impacting 36,000 acres over 30 years and stretching from the Canadian border to Mt Rainier National Park. This project in the MBSNF threatens recreation, wildlife, local economies, and clean air and water, while increasing the likelihood of forest fires. Send the forest service a formal comment to stop this project until it can produce a thorough environmental impact statement. Here's how to take action:

People v Fossil Fuels

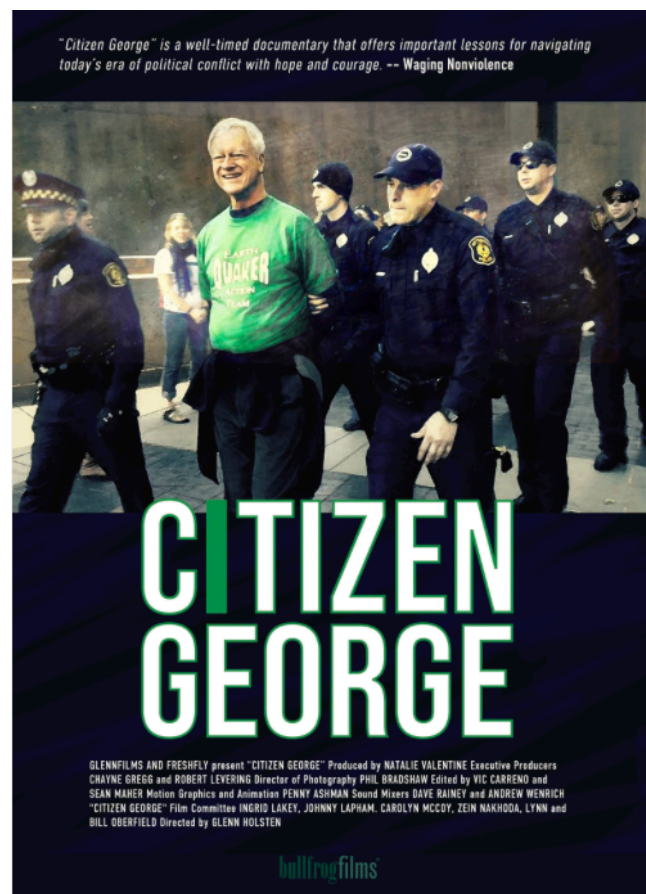
The Trump 5 Year Plan for offshore oil and gas leasing is in the 2nd stage of development, and while Republicans calling for the Atlantic coast to be removed from the plan have succeeded, the plan still includes California, the Gulf, Alaska, and even the “high Arctic” a place never even considered for offshore leasing. These leases would bein addition to the lease sales mandated by congress and would lead to more offshore drilling and seismic airgun blasting in some of the most sensitive habitats on Earth. It’s critical to pack the record with public comments, and NRDC and Ocean Defense Initiative have circulated a strong group letter for sign on calling for no new leasing anywhere.

Healthy rivers and salmon are vital to our way of life in the Pacific Northwest, but Columbia Basin salmon, steelhead, and other native fish are in crisis. “Most wild salmon and steelhead runs persist at a fraction of their historic abundance and geographic distribution, and some (including three of five in the Snake River) persist at less than one percent of their historic abundance” (Source: *Six Sovereigns’ Fish Facts: Columbia Basin Salmon, Steelhead, and Other Native Fish in Crisis*).

Regional Tribes have led important comprehensive and collaborative progress to recover imperiled salmon populations- but salmon recovery efforts and goals are under attack: false and misleading information is being used to defend the harmful status quo, Federal agencies critical to salmon recovery are threatened, habitat restoration funding is in jeopardy, and Bonneville Power Administration is attempting to eliminate their obligation and responsibility to recover wild salmon and steelhead.

How Much is a Farmworkers Life Worth?

How Much is a Farmworkers Life Worth?

Community to Community (C2C)

December 14, 2025: As floodwaters rose in Skagit Valley, the majority of farms and businesses respected the County's emergency evacuation alerts and ceased operations to allow workers to join their families and prepare for the coming floods.

Despite the rising water and the ongoing evacuation alerts, two farms kept their workers in the fields working from before sunrise to after sunset, less than a mile from



the river, some working with heavy equipment that gets easily stuck in the mud. Knutzen Farms continued to operate their potato packing shed with workers inside even as groundwater pooled around them. Skagit Valley Farm had people out harvesting brussels sprouts, from 7am to 7:45pm on Wednesday the 11th and Thursday the 12th. In the community during these days of heavy anxiety over the uncertainty of the Skagit River's dikes breaking, some farmworker families were missing their father, brother and sons because they had been called in to work. The UU Solidarity Initiative

The UU Solidarity Initiative is a nationally coordinated effort of UU and UU-adjacent organizations to provide resources and opportunities to build strong communities of solidarity with immigrant communities who are under attack.

Our goal is to coordinate the resources of UU organizations to do more impactful and accountable immigration work.

We seek to coordinate and reduce duplication of UU work related to immigration. Amplify needs and actions on the ground to wider networks. Reduce unintentional harm to partner organizations and directly impacted folx by UUs/UU orgs. Support UU congregations doing local and regional accountable work.

UURise Tools to Help (Immigration)

From the November 2025 UURise Justice Summit. To implement all of the tactics necessary to support the strategies to achieve the goals, movements need many kinds of contributors—protesters, logistics teams, storytellers, legal observers, caregivers, and more. Through her Building Movements Project, Deepa Iyer's Social Change Ecosystem Map identifies 10 Social Change Roles. This framework makes it easier for people to get involved in justice by identifying on-ramps and off-ramps to meaningful work.

Tools To Help

Asset Mapping: Helps congregations move from intention to action by identifying physical, financial, human, spiritual, and relational resources. Mapping resources allows us to respond quickly to needs and to build liberatory structures. Congregational and community assets are plentiful but often overlooked—mapping them reveals a community's real power.

Power & Relationship Mapping: Builds strategic clarity and turns uncertainty into action. This kind of mapping shows who holds influence, where they stand, where there are existing relationships, where relationships are needed, and how to focus resources and energy for maximum impact.

Social Change Now: A Guide for Reflection and Connection: a workbook by Deepa Iyer that helps you identify which Social Change Roles you can play.

Nisqually Tribe says it won't allow ICE detainees in tribal facilities

The Nisqually Tribe operates its own correctional facility, one of several in Washington state run by tribal governments. That structure gives tribes wide autonomy over detention decisions. Gabe Galanda, an Indigenous rights attorney, said that because tribes are sovereign nations, they are not bound by the Keen Washington Working Act. KWW is the

sovereign nations, they are not bound by the Keep Washington Working Act. RWVW is the state law that bars local and county law enforcement agencies from assisting federal immigration enforcement.

“It’s any tribe’s prerogative to consider collaborating with ICE,” Galanda said. But entering into such agreements, he added, carries significant legal and civil-rights implications. A person held in a tribal detention facility while awaiting immigration proceedings may not have the same protections that would apply in a non-tribal facility, he said.
